

#### PERFORMANCE REQUIREMENTS

It is agreed and understood that the Promoter will provide and pay for all requested equipment as the following rider. The Artist reserves the right to decline to perform if these specific performance requirements in this rider are not met by the Promoter and the Promoter will be held accountable for the Artist's fee and all expenses made as agreed in contract.

### TECHNICAL RIDER

- 3 Pioneer CDJ-2000 CD players linked to each other and should be positioned according as shown on image 1
- 1 Pioneer DJM 800 or DJM 900 mixer
- 2 high quality monitors equipped with volume adjustment controls and preferably powered separately positioned in the DJ booth at ear level of the DJ and <u>not</u> on the ground
- **Sound level** on the dance floor should be at least 100 DB or higher FLATEQ-D within a range of 2 meters
- 1 wireless microphone connected to the DJM 800 / DJM 900 mixer
- All equipment must be properly connected and fully functional and be of good quality meaning buttons and faders must not be broken

## DJBOOTH

- **DJ table** with a height of 1,00 meter
- 1 large table behind DJ booth for e.g. DJ bag
- DJ Booth must be sufficiently lit
- DJ must be visible for audience
- Ceiling above the DJ deck must be 3 meters or higher
- Promoter will provide at least one person for security who will oversee the stage during the performance of Artist
- Artist has the right to decline people in the DJ Booth who are not personnel

#### HOSPITALITY RIDER

- Promoter will provide at least 5 guests lists invitations on the event/location on/in, which Artist is to perform.
- Provider will provide 2 guest list invitation to Artist Manager/Agent
- Promoter will provide an Artist entrance at the location of performance or an entrance which doesn't require Artist to wait in line which could delay arrival and/or Artists performance
- Promoter will supply **sufficient drinks** for Artist:
  - 0,7L Bottle Johhny Walker Black Label OR 1L Bottle White Vodka preferably Grey Goose
  - 6 Red Bull 0,33cl
  - 1,5L 7 up
  - 2 Bottled still mineral water 0,50L, brand EARTH water.

If Promoter is unable to supply the drinks as mentioned above, Promoter will supply coins worth the amount of drinks as mentioned above so that the Artist is able to get drinks at the bar
